### RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE DUE TO THE NEGLIGENCE OR GROSS NEGLIGENCE OF "RELEASEES" OR OTHERWISE while in or upon the restricted area and/or-while competing, officiating, observing or working for or for any purpose participating in the EVENT(S).
