I DO AGREE, BY SIGNING THIS NORTH STAR SPEEDWAY CAR REGISTRATION FORM, THAT I WILL ABIDE BY ALL THE RULES AND REGULATIONS SET FORTH BY NORTH STAR SPEEDWAY, INCLUDING, BUT NOT LIMITED TO THE FOLLOWING:

- 1) I HAVE, OR WILL HAVE FAMILIARIZED MYSELF WITH ALL THE NORTH STAR SPEEDWAY RULES AND REGULATIONS, INCLUDING CAR SPECIFICATIONS, AND SAFETY RULES, AND I SPECIFICALLY AGREE TO ABIDE BY ALL THE NORTH STAR SPEEDWAY RULES
- 2) I AGREE THAT I SHALL BE THE SOLE SPOKESPERSON FOR MYSELF, THE CAR OWNER, AND THE CREW IN ALL MATTERS PERTAINING TO COMPLIANCE WITH THE RULES AND REGULATIONS AND I AGREE AND UNDERSTAND THAT I AM RESPONSIBLE FOR THE CONDUCT OF MY CREW.
- 3) I AGREE AND UNDERSTAND THAT BY SUBMITTING MY RACECAR FOR VARIOUS TECHNICAL AND SAFETY INSPECTIONS, I CERTIFY THAT THE RACECAR MEETS ALL THE RULES AND REGULATIONS FOR THE PARTICIPATION IN NORTH STAR SPEEDWAY EVENTS, AND I UNDERSTAND THAT THE BURDEN OF PROOF WILL REST UPON ME TO SHOW THAT I AM IN COMPLIANCE WITH ALL OF THE NORTH STAR SPEEDWAY RULES AND REGULATIONS, AND I UNDERSTAND VIOLATION OF VARIOUS RULES CAN RESULT IN A FINE, SUSPENSION, AND LOSS OF ALL POINTS.
- 4) I AGREE TO APPROPRIATELY USE ALL REQUIRED STICKERS, DECALS AND PATCHES AND I UNDERSTAND THAT FAILURE TO DO SO WILL RESULT IN LOSS OF POINTS AND FORFEITURE OF ALL MONEY AND AWARDS FOR THE EVENT.
- 5) I AGREE TO PARTICIPATE IN A MINIMUM OF TWO (2) NORTH STAR SPEEDWAY PROMOTIONAL NON-RACING EVENTS DURING THE 2008 RACE SEASON. IN RETURN, NORTH STAR SPEEDWAY WILL GIVE EACH PARTICIPATING DRIVER FIVE (5) FREE GENERAL ADMISSION PASSES FOR EACH NSS PROMOTIONAL EVENT, WITH A MAXIMUM OF TEN (10) FREE PASSES PER SEASON
- 6) I AGREE THAT ALL DECISIONS OF NORTH STAR SPEEDWAY TRACK MANAGEMENT AND TRACK OFFICIALS, REGARDING THE

INTERPERTATION AND APPLICATION OF THE NORTH STAR SPEEDWAY RULES, AND THE SCORING OF POSITIONS, SHALL BE NON-LITIGABLE. I FURTHER COVENANT AND AGREE THAT I WILL NOT INITIATE ANY TYPE OF LEGAL ACTION AGAINST NORTH STAR SPEEDWAY, OF A NORH STAR SPEEDWAY PROMOTER TO CHALLENGE SUCH DECISIONS, TO SEEK MONETARY DAMAGES, TO SEEK INJUNCTIVE RELIF OR TO SEEK ANY OTHER KIND OF LEGAL REMEDY. I UNDERSTAND THAT IF I PURSUE ANY SUCH LEGAL ACTION, WHICH VIOLATES THIS PROVISION, THEN I EXPRESSLEY AGREE TO REIMBURSE NORTH STAR SPEEDWAY, OR THE NORTH STAR APEEDWAY PROMOTER, FOR ALL OF ITS ATTORNEY'S FEES AND OST IN DEFENDING AGAINST SUCH LEGAL ACTION.

- 7) I ALSO AGREE TO RELEASE ALL ADVERTISING AND PROMOTIONAL RIGHTS TO MY NAME, CAR AND LIKLINESS TO NORTH STAR SPEEDWAY TO ITS SPONSORS AND ADVERTISING PARTNERS.
- 8) I UNDERSTAND THAT ALL MONEY EARNED WILL BE PAID TO THE DRIVER.
- 9) I FURTHER UNDERSTAND THAT THERE ISNO EXPRESS OR IMPLIED WARRANT OF SAFETY RESULTING FROM PUBLICATION OR COMPLIANCE WITH THE NORTH STAR LATE MODEL, SPORTSMAN, TRUCK, MINI-STOCK, THUNDER/STREET STOCK, LEGENDS, BABY GRANDS, OR GENERAL RULES AND THAT THEY ARE INTENDED AS A GUIDE FOR THE CONDUCT OF THE SPORT AND ARE IN NO WAY A GUARANTEE AGAINST INJURY OR DEATH TO PARTICIPANTS, SPECTATORS OR OTHERS.
- 10) I CERTIFY THAT AT THE TIME OF SIGNING THIS APPLICATION, I AM IN FACT AT LEAST EIGHTEEN (18) YEARS OF AGE, IF I AM UNDER WIGHTEEN (18) YEARS OF AGE A "MINOR'S WAIVER AND RELEASE" HAS BEEN COMPLETED BY A PARENT OR LEGAL GUARDIAN.
